In terms of the South African Reserve Bank Act 90 of 1989, as amended (SARB Act) and the Regulations framed in terms of the said SARB Act (Regulations), the terms of office of three shareholder-elected non-executive directors of the Board of directors (Board) of the South African Reserve Bank (SARB) will expire at the next annual Ordinary General Meeting (AGM) to be held on 30 July 2024.

Any shareholder, director of the SARB or any member of the public may nominate persons to be considered as a candidate to serve as an elected non-executive director of the SARB. The SARB Act requires Board members to have knowledge and skills in particular aspects of the economy. The vacancies that will arise requires that nominees should have skills and knowledge in the mining, labour, and commerce or finance sectors.

Attached hereto are nomination and consent forms, a format for the submission of a curriculum vitae of the nominated candidate, and a statement to be completed and signed by the nominator, seconder and the nominated candidate. 

 - iv. is a member of Parliament, or a provincial legislature or a municipal council member; or
 - v. is an unrehabilitated insolvent; or
 - vi. was dismissed from a position of trust as a result of his/her misconduct or has been disqualified or suspended from practising any profession on the grounds of his/her professional misconduct; or
 - vii. was convicted of an offence listed in Part 1 or 2 of Schedule 1 to the Criminal Procedure Act 51 of 1977, an offence under this Act, the Prevention and Combating of Corrupt Activities Act 12 of 2004, the Prevention of Organised Crime Act 121 of 1998, the Prevention of Counterfeiting of Currency Act 16 of 1965, perjury, or any other offence involving an element of dishonesty in respect of which he/she has been sentenced to imprisonment without the option of a fine or to a fine exceeding R1 000; or
 - viii. is mentally or physically incapable of performing the duties of a director; or
 - ix. is contractually incapacitated; or
 - x. is an employee of the Government of the Republic.
- 5. I confirm that I have no judgment(s) against me for any outstanding loan/debt and that I have never been sequestrated.
- 6. I consent to the SARB verifying any information which I provide, including but not limited to, information pertaining to my credit and financial history.


