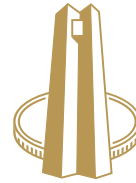

## **Exchange Control Circular No. 10/2024**

### **Cancellation of Master Currency (Pty) Limited as an Authorised Dealer in foreign exchange with limited authority**

The appointment of Master Currency (Pty) Limited (Master Currency) as an Authorised Dealer in foreign exchange with limited authority (ADLA) has been cancelled with immediate effect.

The name of Master Currency will be removed from sections A.2(A) and A.2(B) of the Currency and Exchanges Manual for Authorised Dealers in foreign exchange with limited authority and the Currency and Exchanges Manual for Authorised Dealers (Manuals), respectively, as well as in the guideline documents for business entities and individuals (guideline documents).


